
Sub:- Land allotment recommendatory committee.

A number of proposals are being received in office of the Chief Minister from the NGOs/ other agencies for allotment of land on concessional rates to carry-out their activities. The matter has been deliberated upon and it has been decided that in cases / activities for which the Delhi Development Authority (DDA) has a declared policy for auction of plots, no recommendation will be considered by government of National Capital Territory of Delhi or sent to DDA.

As per the current policy of the DDA most of the institutional land is allotted through auction. This includes land for schools and hospitals. However, for socio-economic and cultural institutions including old age home, children home, library and community centre etc. land can be allotted at a specified rates to genuine institutions / registered societies on the basis of the recommendations received from the State Governments / Central Government. The recommendations from the State Governments / Central Government is only a precondition for allotment. The DDA has its own procedure for scrutinizing the applications after they have been recommended by the Central Government / State Governments. Earlier each department of government of National Capital Territory of Delhi used to recommend cases for allotment of land of the concerned institutions relevant to their departments. This process has now been discontinued.

The following procedure is now recommended for processing such applications:

- 1) The administrative department concerned would scrutinize the proposals and verify the claims made by the societies / institutions by carrying site visits as well as looking into the relevant documents and track record of the society. The character and antecedents of the NGO will be verified / certified by the


administrative department concerned of the government of National Capital Territory of Delhi.

- 2) On receipt of the reports from the department, the same may be placed before the Land Allotment Recommendatory Committee headed by the Hon'ble Minister, Urban Development, GNCTD and consisting of the following members:


