(B)Educational Qualifications and Experience: Post Graduate Degree in Town or City or Urban or Housing or Country or Rural or Infrastructure or Regional or Transport or Environmental Planning from a recognized University or Institute with 15 years experience in Govt. Organization or reputed Private Organization /Institutions in the field of Town or City or Urban or Housing or Country or Rural or Infrastructure or Regional or Transport or Environmental Planning.

Retired Group 'A' Gazetted Officer from any Central Government/State Government/Union territory Administrations/ Boards/ Corporations /PSUs/Autonomous body of which 05 years should be in Govt. (C)TERMS AND CONDITIONS OF APPOINTMENT

- (a) The engagement of the candidate shall initially be for a period of one year which can be extended beyond one year on satisfactory performance after the approval of the Competent Authority, but in no case it shall be beyond 65 years. The extension beyond one year on every occasion shall be with the prior approval of the Competent Authority.
- (b) The pay shall be determined as under:
- i) The remuneration of retiree/ pensioner of his/her engagement will be fixed at the stage of the last basic pay drawn by him before retirement minus pension before commutation plus DA as applicable from time to time. No other allowance, whatsoever, shall be payable to him/her. However, he/she will continue to draw separately any pension sanctioned to him/her and shall retain any other form of retirement benefits;
- ii) The remuneration of candidate other than in Central Government/State Government/Union territory Administrations/ Boards/ Corporations /PSUs/Autonomous body shall be fixed with the approval of the Competent Authority.
- (c) The candidate engaged on contract basis shall be entitled for leave as per DOP&T Orders, GOI and no leave of any other kind will be admissible. In case of availing leave beyond this limit, his/her salary shall be deducted on pro rata basis;
- (d) The candidate engaged on contract basis shall observe office hours as per the norms of the department /organization in which he/she shall be engaged. Further, he/she shall devote his whole time to his duties during the period of contract and shall not accept any other appointment/ engagement, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.
- (e) Engaging of the candidate shall purely be contractual arrangement and he/she shall have no right against the post whatsoever and shall not be entitled to any other benefit except salary as mentioned above;
- (f) The services of the candidate shall be discontinued by giving one month's notice from either side at any time.
