The 17 agenda items were considered by State Names Authority and following were the decisions:

#### Item no. 1

### Renaming of Gurudwara Nanak Piao Chowk as Bibi Nanki Chowk

Gurudwara Nanak Piao is a historical place and named after Guru Nanak Devji. Therefore, its renaming was not considered as appropriate.

#### Item no. 2

#### Naming of DDA Nasir Pur Pocket No.6 to 10 as Sector-1 (A), Dwarka

Sector I Dwarka already exists. DDA's proposal to name Nasirpur Pocket 6-9 as Sector 1 (A) Dwarka would lead to confusion, therefore, the proposal was not approved.

# Naming any road after the name of late Sh. Jaya Nand Bhartia

State Names Authority was of the view that roads in Delhi should be named after the persons with National and International fame or those who who have made notable contribution to the development of Delhi. Late Sh Jaya Nand Bhartia's had spent his life largely for the betterment of Uttrakhand. The proposal was therefore not considered.

The Authority however, decided to defer the consideration of the proposal pending framing of guidelines for names of roads in New Delhi area after trees and flowers. The suggestion of NDMC and DDA on the above should be ascertained and brought to the Authority in the next meeting.
