ORDER

Consequent upon Trifurcation of Erstwhile Municipal Corporation of Delhi into Three Municipal Corporations, it is hereby ordered that officers and staff posted in Municipal Taxation Tribunal, Govt. of NCT of Delhi from the erstwhile MCD shall continue to be posted and work in the Municipal Taxation Tribunal till further orders. List of the officers and staff presently working in M.T.T. and their respective Corporations where they are substantively posted is annexed at Annexure-'A'. It is further ordered that officers and staff posted in Municipal Taxation Tribunal will continue to draw their pay and allowances from their substantive place of posting in the respective Municipal Corporation.

Further, North Municipal Corporation is assigned the work of Lead Corporation with respect to the administrative and financial matters of Municipal Taxation Tribunal and whatever expenditure would be incurred on the Municipal Taxation Tribunal, would be apportioned in the ratio of 1:1:0.6 among North, South and East Corporation, respectively.
