NOTIFICATION

Subject: Composition of Task Force for setting up of Delhi Unified Metropolitan Transport Authority (DUMTA) and Delhi Urban Transport Fund (DUTF)

(i) The National Urban Transport Policy envisaged creation of a **Unified Metropolitan Transport Authority (UMTA)** in large cities to facilitate strategic planning and co-ordinated implementation of integrated urban transport systems. The increased Population, Pollution, Pressure on Roads and elevated demand of streamlined and organised public transport system in Delhi/NCR is necessitating to set-up a **Delhi Unified Metropolitan Transport Authority (i.e. DUMTA)** for (i) preparation of a Comprehensive Strategic Mobility Plan and a Transport Investment Programme (ii) Establishing effective co-ordination among various urban transport agencies in Delhi/NCR (iii) Management of the Delhi Urban Transport Fund etc.

(ii) In view of the above, a Task Force to finalise the structure of DUMTA, stakeholder consultation, assist in enactment of DUMTA Bill and organising the board meetings with objective of identifying and finalizing the vision, mission, and goals of DUMTA & any other action required for operationalizing DUMTA in Delhi is hereby constituted with the following composition:

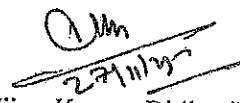

(III) Functions & Powers of Task Force:

- **Finalisation of DUMTA structure:** Geographical coverage, institutional arrangement, composition of DUMTA Board, organisational structure etc.
- **Stakeholder Consultations:** With state & central level agencies, public & private institutions, local associations for finalisation of draft DUMTA Bill
- **Assistance in enactment of UMTA Bill:** It will be required to undertake all activities on behalf of the Nodal Agency in passing the legislation for enactment of the Bill by the State Government
- **Assistance in organising Board Meetings:** With the objective of identifying and finalizing the vision, mission, and goals of DUMTA & any other action required for operationalizing DUMTA

(IV) The Task Force shall submit the report within three (03) weeks on the formation of DUMTA and DUTF.
