  executive agencies.

Separate cheque is required in respect of refund of unspent balance/saving/penalty levied and interest thereon in the name of PAO-VI.

6. The funds under the MLALAD Scheme will be utilized by the agencies strictly in accordance with the existing guidelines and with the parameters of the scheme on approved item of work as amended from time to time. The executing agencies

will strictly follow the provisions as per CPWD work manual.

The implementing agency will observe all the codal formalities, the provisions of GFRs-2017, CVC guidelines and orders of Finance Department, Delhi Government issued time to time for execution & award of the work and also to observe all guidelines issued by UD Deptt. time to time.

The utilization certificate for the current financial year alongwith expenditure statement duly certified by the audit should

be submitted as per GFRs.

Executing Agency will maintain a separate Inventory/Stock Register for items procured under MLALAD Scheme.

10. The progress of works will be monitored, both in physical and financial terms on monthly basis by the Executing Agency and quarterly reports will be furnished to UD Department, GNCTD regularly.

11. All the works approved for execution in each MLA constituency under MLALAD may be uploaded in the public domain

for information of the public and for the purpose of social audit.

12. The Executive Agency is directed to ensure Geo-Tagging of the work executed by them in sanction unscrupulously and ensure that there is no overlapping/duplicacy of work.
