- 9. Executing Agency will maintain a separate Inventory/Stock Register for items procured under MLALAD Scheme.
- The progress of works will be monitored, both in physical and financial terms on monthly basis by the Executing Agency
  and quarterly reports will be furnished to UD Department, GNCTD regularly.
- 11. All the works approved for execution in each MLA constituency under MLALAD may be uploaded in the public domain for information of the public and for the purpose of social audit.
- 12. The Executive Agency is directed to ensure Geo-Tagging of the work executed by them in sanction unscrupulously and ensure there is no overlapping/duplicacy of work.
