Separate cheque is required in respect of refund of unspent balance/saving/penalty levied and interest thereon in the name of PAO-VI.

The executing agencies will strictly follow the provisions as per CPWD work manual.

9. Executing Agency will maintain a separate Inventory/Stock Register for items procured under MLALAD Scheme.

 The progress of works will be monitored, both in physical and financial terms on monthly basis by the Executing Agency and quarterly reports will be furnished to UD Department, GNCTD regularly.
