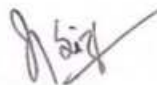

I am further directed to request you to kindly award the work after following all the rules, regulations & codal formalities and submit the proposal with the tendered amount to this department immediately. This



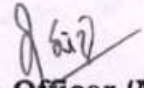

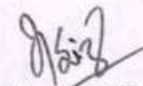
