

The above mentioned display board, in addition to the Content pertaining to the project/work following should also be mentioned along with photograph of Hon'ble CM:-

2. There should be duplicity of work/ payment proposed by the executing agency.

4. It may be insured that works have been completed as per terms and conditions of agreement/CPWD Manual GFR/ CVC guidelines and various orders issued by Govt. from time to time.

In addition to above conditions, the condition mentioned in the previous sanction for release of 1<sup>st</sup> installment shall be applicable to this sanction also.
