- 2. The total expenditure incurred shall not exceed beyond the A/A & E/S without the permission of the compete authority i.e. UD Department.
- 3. Funds under the Scheme shall be released in three installments. 1st installment of 25% of estimated cost at the tin of sanction of project/scheme. 2nd installment of 50% of the work/project i.e. Tendered Amount (-25% of 1 installment) after awarding work order and upon proposal submitted to UD Department and remaining 50% of the work order at the time of completion of work.
