- Funds under the Scheme shall be released in three installments. 1st installment of 25% of estimated cost at the time of sanction of project/scheme. 2nd installment of 50% of the work/project i.e. Tendered Amount (-25% of 1st installment) after awarding work order and upon proposal submitted to UD Department and remaining 50% of the work order at the time of completion of work.
- The time period for change of location/substitution of work is within six months for the works sanctioned under MLALAD Scheme after insurance of this Sanction order.
- 4. The Executing Agency will obtain No Objection Certificate from Land Owing Agency before the award/execution of work.
- The pregress of works will be monitored, both in physical and financial terms on monthly basis by the Executing Agency and quarterly reports will be furnished to UD Department, GNCTD regularly.
