- All payments to the contractor shall be made through electronic mode i.e. RTGS, NEFT and ECS by their respective executive agencies.
- The unspent/saving/penalty levied on the contractor on any account will be refunded/ deposited to the UD
  Department along with interest if any, after completion of work. Separate cheque is required in respect of
  refund of unspent balance/saving/penalty levied and interest thereon in the name of PAO-VI.
- The funds under the MLALAD Scheme will be utilized by the agencies strictly in accordance with the existing
  guidelines and with the parameters of the scheme on approved item of work as amended from time to time.
  The executing agencies will strictly follow the provisions as per CPWD work manual.
- 7. The implementing agency will observe all the codal formalities, the provisions of GFRs-2017, CVC guidelines and orders of Finance Department, Delhi Government issued time to time for execution & award of the work and also to observe all guidelines issued by UD Deptt. time to time.
