Minutes of the 48th meeting of Trans Yamuna Area Development Board held on 25.5.2011 at 11.30 A.M in the Conference Hall No. 3, IInd Level, Delhi Sachivalaya, I.P.Estate, New Delhi under the Chairmanship of Dr. Narender Nath.

List of participants who attended the meeting is annexed.

Initiating the discussion Chairman TYADB welcomed all the members of the TYADB. Thereafter scheme-wise/agency-wise financial expenditure and Physical achievements of ongoing projects under TYADB up-to the year 2011-12 was discussed in detail.

- 1.01 All the Members of the Board desired that HODs of MCD, DJB, I&FC and Slum Board who are the Board Members should attend the Board's Meeting in future regularly.
- 1.02 The chairman stressed the need for joint inspections of sites by Chairman (TYADB), Area MP and Area MLA alongwith concerned officials of the executing agency to assess the requirement of new works. Thereafter the proposal of new works will be placed before the Board during the year 2011-12.
- 1.03 Chairman (TYADB) proposed the following scheme-wise budget for each constituency for the year 2011-12 for execution:-

(A) M.C.D

Each MLA was allowed to carry out development works in their constituency of:-

- 1.01 Rs. 70.00 lacs for works out of which Rs. 10.00 lacs allowed to be utilized for Horticulture works. or 10lacs for improvement of Parks/Environment, if required in x(i).

(Action-CE-VII, CE-X, CE-XI & Director(Hort. MCD)

- 1.02 Rs.5.00 lacs or more towards improvement of High Mast lights as per requirement of each constituency from Head XL VIII x(i).

(Action: CE- III, CE-Electrical, MCD)

- 1.03 Rs.6.00 lac each for street lights and High Mast Light in parks/crossings etc. and the funds was also allowed to be used for both or on any single above mentioned component. The, change of scheme (Head) may not be allowed to be carried out, if there is no park in constituency.

(Action: C.E.-III, CE-Electrical, MCD)

- 1.04 Rs.25.00 lacs for development works in unauthorized regularized colonies and Rs.30 lacs for dense carpeting/Mastic and Rs.900.00 lacs for construction of Barat Ghar/Community Centers etc..

(Action: - CE-VII, MCD)

- 1.05 Chairman (TYADB) desired that all the MLAs of the TYADB shall also submit proposals relating to their areas within the size of above mentioned allocated fund to UD Deptt. for inclusion in the area plan and for its implementation in the year 2011-12.

(Action: concerned MLA, Members of TYADB and Agencies,)



3.0 The Chairman (TYADB) proposed the earmarking of Rs.1.00 Cr. For each MLA constituency for carrying out replacement of old waterlines and improvement of sewer line works during the year 2011-12 out of the total fund allocated for water works under TYADB. The list of works shall be furnished by the member MLA to Delhi Jal Board and a copy to UD Department upto 30th June, 2011.

3.01 The concerned offices of DJB will take the consent of concerned MLA for change of water/sewer line upto 30th June, 2011 and Delhi Jal Board will prepare the action plan thereafter he will write to MCD to take permission of road cutting and Delhi Jal Board will also submit the road cutting charges to MCD before starting the work in the area.



- 3.02 The Board decided and told to CE East Delhi Jal Board to purchase or hire 5 Nos. of LCV mounted combines High Mast Pressure Jetting and sewage suction machine Model TPS-VAC-JET-SSM-040 for maintenance of sewer lines for Trans Yamuna area including O&M cost for one year i.e. 2011-12.
