Subject:

Scheme for Waiver of LPSC and slab-wise Waiver on accumulated arrears.

Decision:

Minister (Water) moved a proposal for the consideration of Council of Ministers as in the enclosed Note (Annexure-A) containing the Scheme for Waiver of Late Payment of Surcharge (LPSC) and slab-wise Waiver on accumulated arrears in respect of the DJB's domestic individual and bulk water connections.

After deliberation, the Cabinet approved the proposed Scheme as well as its salient features, with the modifications that (i) 'D' category of colonies shall be given a rebate of 75% instead of the proposed 50% (the rest remaining same), and (ii) the amount waived off by DJB will not be reimbursable by the GNCTD. However, DJB will continue to receive possible financial support under the GNCTD Budget, as approved every year.

## <u>ORDER</u>

# Sub: - Waiver of Late Payment Surcharge (LPSC) and slab wise waiver of accumulated arrears.

In Compliance of Cabinet Decision No. 2288 dated 13.02.2016, competent authority has ordered Waiver of Late Payment Surcharge (LPSC) and slab wise waiver of accumulated arrears in respect of Delhi Water Boards domestic individual and bulk water connections. As per above Cabinet Decision, the water bills of domestic category will be settled as per following formula.

The above scheme will be implemented subject to following eligibility criteria and conditions.

#### **Eligibility Criteria:**

- All domestic (individual and bulk) consumers of DJB, having a functional water meter will be eligible (ii)
- All such consumers who are already having functional water meters and those consumers who will install the meter before the closing date of the scheme will be eligible under the scheme. To avail the benefit of above scheme, consumers shall clear the arrears due by 31-07-2016. (B) Salient Feature of the Scheme:

- The cut-off date for arrear will be the amount due against a consumer as on 30-11-2015 i.e. completion of billing Round IV of 2015-16. (ii)
- The scheme will be operative from 15.02.2016 to 31-07-2016.
- Under the scheme 100% LPSC waiver will be given to all domestic consumers whereas concession (iii) in principle amount will be on the basis of category of colonies done for House Tax purposes in Municipal Corporations as per formula given above.
- A consumer is required to pay the net amount after deducting 100% LPSC amount from the arrears and further rebate in the principle dues, if any, as per the category mentioned above, on or before the closing date of the scheme i.e. 31-07-2016 but after installing a working meter as specified by the Board, if not installed. (v)
- Consumers who will install the meter after commencement of the scheme would be required to diary their representation giving their Name, K.No. and document of meter installed showing Meter No., Make and certificate with the respective Zonal Revenue Office. Waiver of LPSC and principle arrear as due and eligible would be given automatically in the ensuing water bill. (vi)
- Such consumers who have intimated that they have installed a functional water meter and availed the benefit of the scheme but during the site inspection in the subsequent billing round, meter is not found functional, such consumer will be required to install a functional water meter within 15 days from the date of inspection and intimated to the consumer. Failing which the Z.R.O. will be empowered to fix average as per the estimated consumption of the connection or 25 KL per month whichever is higher. Appeal of which will lie with respective area Jt. Dir. (Revenue)/ Dy. Dir. (vii)
- The benefit of waiver off 100% LPSC will be reflected in the water bills generated after the launch of the scheme in respect of all consumers. Waiver of principal amount as per the category will be

given on payment of net amount due after rebate on principal amount. However, in the case of consumer of E, F, G & H colonies where 100% waiver on principal demand is also applicable, same will be reflected in the next bill generated by the Board after the launch of the scheme.

- (viii) During the course of scheme, late payment surcharge will not be levied on the consumers.
- (ix) Similarly, if due to any error etc., if the rebate is not reflected in the subsequent water bill inspite of fulfilling the conditions by the consumer, respective area Jt. Dir. (Revenue)/ Dy. Dir. (Revenue) may grant the benefit at their level to the consumer in RMS.
- (x) Consumers who either fail to install Meter and inform about it to their respective Z.R.Os or, pay the due arrears after rebate by 31<sup>st</sup> July, 2016, will not be able to avail the benefit of the rebate scheme and, are required to pay the full amount of arrears besides other due punitive action including disconnection, under DJB Act/Regulations.
- (xi) The scheme is proposed to be operational upto 31-07-2016. Based on the response and other factors, the scheme may be extended beyond 31-07-2016, with the approval of the Chairman, Delhi Water Board.
- (xii) The implementation of the above scheme is proposed from 15.02.2016-31.07.2016

#### (C) Financial implication:-

The amount waived off by Delhi Water Board on above account will not be reimbursable by Government of NCT of Delhi. However, Delhi Water Board will continue to receive possible financial support under the GNCTD Budget, as approved every year.
