ORDER

Sub: - Implementation of recommendation under Master Plan for Artificial Recharge to Ground Water in India-2013.

Central Ground Water Board, M/o Water Resources, Government of India has published the Master Plan for Artificial Recharge to Ground Water in India-2013. The Para 8.4 of this report consists recommendation regarding steps to be taken to harness the net available run off through injection wells in Urban area, check dams in ridge area and roof top Rain Water Harvesting in private buildings as well as government buildings in National Capital Territory for Ground Water Recharge. The above report was placed before Hon'ble Supreme Court of India in the matter of Writ Petition (C) No(s). 252/2005, TREE & ANR. Versus UNION OF INDIA & ORS. Hon'ble Supreme Court in the above matter vide order dated 30.01.2017 has directed the following -

"Mr. P.S. Patwalia, learned Additional Solicitor General, has handed over to us the Master Plan for Artificial Recharge to Ground Water in India, for the year 2013. He states, that all individual State Governments, must implement the same, for recharge of ground water in India, as suggested in the Master Plan.

In view of the above, all the State Governments shall file affidavit in this Court within two weeks from today, with copies to the Additional Solicitor General, as also, to the learned counsel for the petitioners, affirming whether or not they would implement the Master Plan, 2013."

It is therefore, directed that all departments/agencies shall ensure that above recommendations are duly implemented in their departments/agencies. Each department/agency will make sufficient budgetary provision in their budget/Annual Plan for the purpose. A compliance report may also be furnished to this office within 4 weeks time.
