Sub:- Clarification for the operation of fogging machine

Sir,

Please refer to your office letter no. F.NO./SDM/DUDA(Shahdara)/2016-17/111 dated 26.4.2016 on the subject cited above. In this regard the pointwise clarification are as under for your information and necessary action at your end:-

1. Can the payment for consumables be made from MLA-LAD Fund. - **Yes**
2. Can the manpower required for the operation of these fogging machines also be paid from the MLA-LAD Fund? - **No.**
3. What should be the physical and technical requirement for engaging the manpower? - **Does not arise in response to point no. 2**
4. Petrol, Diesel and chemical is required for the operation of these machines, as all these items are highly inflammable and hazardous in nature, where these are supposed to be stored safely? - **Operation and stores of consumable items can be worked with the concerned Municipal Corporation as they are also supposed to carry out these activity regularly.**
