- 15. The Executing agencies will also ensure that the work estimate has been checked by their Planning Section and approved by the Competent Authority as per Delegation of Financial Power before execution of the works.
- 16. The executing agency will be responsible for technical and financial scrutiny and approval of detailed estimate for each work.
- The executing agency will observe the provisions of GFRs and work manual for execution & award of the work.
- 18. Copy of Cost of Index over DSR should be provided to UD Department by the executing agency and Cont. is allowed 1% instead of 3% before execution of work.
- 19.
