Five Hundred Twelve lakhs and Sixty Seven Thousand only) for the execution of the following improvement/developmental works relating to roads and drainage in the Assembly Constituency of Sh. Mangat Ram Singhal, Hon'ble MLA, Adarsh Nagar (AC-4) under the plan scheme "Additional Facilities in JJR Colonies".

The expenditure will be met under MH-2217 A.8(1)(1)(2)(1)-Grant-In-Aid to North Delhi Municipal Corporation for provision of Additional Facilities in JJR Colonies in demand No.11 during the current financial year-2013-14 subject to the following conditions. The funds under this head will be released to North DMC alongwith the other plan schemes under different heads during the year 2013-14 in due course.

- 1. While inviting tender, the estimate has to be prepared separately for each work as per DSR-2012, minus(-)12% over DSR-2012 + 3% or 1% contingencies, as the case may be, in terms of Finance Deptt's order no.8/2/2007-A/CD-01295543/2012-13/Exp.-4/854-73 dated 12.09.2012(copy enclosed).
- 2. No diversion of funds from one work to another work may be made without the approval of Government of NCT of Delhi.
- 3. The physical achievement report and monthly expenditure statement should be submitted separately.
- 4. The assets acquired wholly or substantially out of Govt. grants should not, without the prior sanction of this Deptt. be disposed off, encumbered or utilized for purposes other than those for which the grants are sanctioned.
- 5. The Grant-in-Aid shall be subject to detailed scrutiny by Directorate of Internal Audit, Govt. of NCT Delhi.

- 6. The account of the North DMC relating to this Grant-in-Aid will be open to test check by the Comptroller & Auditor General of India at his discretion.
- 7. Due prudence and frugality shall be exercised by the North DMC while incurring Expenditure out of GIA and no wasteful expenditure whatsoever shall be incurred in any manner.
- 8. Expenditure will be incurred only for the purpose for which GIA has been sanctioned and for the targets, which have been assigned to the North DMC by the Urban Development Department.
- 9. The UD Department shall carry out periodical appraisal of the performance of the North DMC for ascertaining as to whether the targets/goals assigned to the North DMC are being achieved and as to whether the GIA should be continued or not.
- 10. North DMC should furnish the utilization certificate of the previous years in form GFR-19 A at the time of moving the proposal for release of next installment of Grant-in-Aid.
- 11. The procedure as prescribed in GFR and the OM / Circular by FD/CVC is duly followed while purchasing goods / services and while executing projects works contract.
- 12. North DMC will lay down adequate control mechanism / checks for prevention and detection of errors and financial irregularities in the working / functioning of subordinate / grantee institution for avoiding wasteful expenditure and loss of money.
- 13. North DMC will ensure that the mechanism / checks contemplated in para (11) are effectively applied for ensuring that the funds are utilized for the prescribed purpose only.
- 14. The following pattern of assistance shall be observed by the North DMC.
  - I. The directives/orders issued by the Government from time to time regulating expenditure out of grant-in-aid shall be binding on the North DMC and contravention thereof shall render the GIA liable to be withheld.
  - II. The North DMC shall not do any act or undertake any activity which entails additional financial liability from the Government without the approval of UD Department and Finance/Planning Department, GNCTD.

#### ORDER

Sub: Adoption of DSR-2012 in place of DSR-2007 for capital works in National Capital Territory of Delhi

In partial modification of Government Order of even No.PA/DSF/Misc./2012-13/Exp.-4/538-45, dated May 17, 2012 and subsequent corrigendum dated May 23, 2012 regarding revision of delegation of powers for sanction of capital works/projects, observance of standard norms/parameters and guidelines for approval/sanction of capital works, Lieutenant Governor, Delhi is pleased to approve the adoption of Delhi Schedule Rates-2012 (DSR-2012) in place of Delhi Schedule Rates-2007 (DSR-2007) for capital works/projects of Government of NCT of Delhi to be executed by the work executing agencies including PWD, I&FCD, DSIIDC, DTTDC, DUSIB, DTIDC and local bodies as per following rates/stipulation:

The adoption of DSR-2012 is further subject to the followings:

- (i) Contingency, third party quality control, labour cess and art work (wherever necessary) shall continue to be charged @ 1% each.
- (ii) Consultancy charges (wherever necessary) shall be fixed lump sum subject to a maximum of 3% of original project cost, and
- (iii) Project Management charges/Department charges to agencies other than PWD and I&FCD shall be restricted upto a maximum of 5% of the original project cost.
