Sub: Clarification on the guidelines issued from the Office Divisional Commissioner in respect of DUDA of various Districts
Sir.

Kindly refer to your office order No. F. 36(74)/Coord./Div.Com./2015/4156 dated 31.08.2015 vide which guidelines was issued with a view to have uniformity in functioning of District Urban Development Agency of various districts.

In this regard, it is informed that the above guidelines was perused by this Department and it was observed that there is only one point/para mentioned at Sl. No.4 of the guidelines reproduced below, on which clarification is required to be given from this Department taking into consideration of the relevant orders issued by Govt. of Delhi time to time.

"5% of the funds under various schemes shall be utilized as establishment/administrative expenses for payment of salary, stationary, POL and other miscellaneous expenses. However, interest income shall be utilized on execution of the scheme/works only"

On the above point/para of the guidelines, I am directed to convey the clarification of Government of Delhi given as under:-

"MLALAD scheme alongwith other Plan Schemes will be implemented through DUDA. Under MLALAD Scheme, there is no provision of giving 5% departmental charges to the Executive Agencies. It is to clarify here that only in those cases where DUDA itself is the Executive Agency, it is entitled to take 5% Departmental Charges as per Finance Department order dated 10.09.2014(copy enclosed). Moreover, the Executive Agencies under this Scheme are to deposit interest on accrued income in the account of Govt. of NCT of Delhi. Now, the MLALAD Scheme will be implemented exclusively through DUDA itself, as such, 5% departmental charges as per order of Finance Deptt. shall not be applicable in DUDA".

#### ORDER

Sub: Adoption of DSR-2014 in place of DSR-2012 for capital works in National Capital Territory of Delhi.

In partial modification of Government Order of even No.F.8/2//2007-AC/CD-01295543/2012-13/Exp-4/854-73 dated September 12, 2012, Lieutenant Governor, Delhi is pleased to approve the adoption of Delhi Scheduled Rates-2014 (DSR-2014), DPAR-2014 (Civil works) & DSR-2014 (Electrical works) in place of Delhi Scheduled Rates-2012 (DSR-2012) for capital works/projects of Government of NCT of Delhi to be executed by various work executing agencies including PWD, I&FCD, DSIIDC, DTTDC, DUSIB, DTIDC and Local Bodies as per following stipulations:

S.N	Nature of works	Existing Stipulation as per GO dated 12.9.2012	Revised Stipulation
1.	Bridge works	DSR-2012 minus 5%	DSR-2014 minus 5%
2.	Building works	DSR-2012 minus 12%	DSR-2014 minus 12% DPAR-2014 minus 12%
3.	Development works (Roads & side drains)	DSR-2012 minus 12%	DSR-2014 minus 12%
4.	Electrical works		DSR-2014

- 2. The adoption of DSR-2014, DPAR-2014 and DSR-2014 (Electrical) is further subject to the followings:
  - i. Contingency, third party quality control, labour cess and art work (wherever necessary) shall be continued to be charged @ 1% each
  - ii. Consultancy charges (wherever necessary) shall be fixed lump sum subject to a maximum of 3% of original project cost for work costing above ₹30.00 crore whereas consultancy work shall not be outsourced for projects costing upto ₹30.00 crore.
  - iii. Project Management charges/ Departmental charges to agencies other than PWD and I&FCD shall be restricted to maximum of 5% of the original project cost.
- 3. The adoption of DSR-2014, DPAR-2014 for civil works and DSR-2014 (Electrical) for electrical works will be applicable only for estimation/sanction of new projects. The work already sanctioned or being executed or in the process of tender on the basis of estimation prepared on earlier DSRs shall not be reviewed with reference to this order.
