Sub: **Constitution of Delhi Village Development Board**

Sir,

Presently, two development boards i.e. Trans Yamuna Area Development Board and Delhi Rural Development Board are functioning in Delhi. Now, Govt. of NCT of Delhi has decided to wind up these boards as they no longer seems to serve fruitful purpose.

A new advisory board i.e. Delhi Village Development Board is to be constituted under the administrative control of the Development Department which will look after the development works of all rural and urban villages of Delhi.

The nature of the board shall remain advisory and the works recommended by it shall be executed by different executive agencies. It would not only avoid duplicity of work and avoidable administrative expenditure but would also act as an expert body suggesting holistic development works in Delhi villages only. Development Department, GNCTD shall keep an appropriate budgetary provision for these schemes from the next financial year i.e. 2016-17.

It is therefore, requested to kindly look into the matter and prepare a cabinet note for constitution of the Delhi Village Development Board since the Trans Yamuna Area Development Board was constituted with the approval of Council of Ministers vide Cabinet Note dated 04.03.1994 (copy enclosed).

This issues with the prior approval of Hon'ble Dy. Chief Minister, Delhi.
