- (1) P/L dense carpeting from near H.No. T-11 (Near H.No. F-92) to near Multani Factory O.I.A Ph- I in Tekhand Village W. No. 199/C.N.Z amounting to **Rs. 4.22 Lakh** as mentioned at S. No. 6.
