ORDER

The Government of NCT of Delhi has decided that;

1. The Plan Scheme namely "Beautification of Entry Points of Delhi" is now transferred to the Tourism Department, GNCTD so that other entry points could also be planned for beautification instead of just confining to Guru Teg Bahadur Memorial at Singhu Border.
2. The Plan schemes namely "Sanitation in JJR Colonies" and "Sanitation in Unauthorized Colonies" are merged in a single main scheme i.e. "Mechanisation of Conservancy and Sanitation Services".
