**ORDER**

In continuation of this office order No. 18B(101)/UD/Plg/DUDA/ 2015-16/ 3816-3919 dated 16.07.2015, Government of NCT of Delhi has further decided that:-

Development of Urbanized Villages & Renovation/Improvement of Chaupals in Urban Villages shall also be implemented through Delhi District Urban Development Agency (DUDA) functioning under each Revenue District of Delhi. Revenue Department, GNCTD shall keep an appropriate budgetary provision for these schemes from the next financial year i.e. 2016-17 & onwards.

As regards implementation of these two schemes, the area MLA will give consent to Chairperson of DUDA for execution of work, release of specific amount and name of agency by which work has to be executed. The DUDA will approve and execute these schemes itself or get the work executed by any Government Agency. The Executive Agency including DUDA will obtain permission for execution of work from Land Owning Agency and each Executive Agency including DUDA shall also maintain assets register for structures/assets created under these schemes.

This issues with the prior approval of Hon'ble Dy. Chief Minister, Delhi.
