Sub:- Minutes of the Meeting held on 24.2.2016 for Execution of works under District Urban Development Agency (DUDA)

A meeting regarding the execution of works by the three Municipal Corporations of Delhi through District Urban Development Agency (DUDA) was held under the chairmanship of Hon'ble Chief Minister on 24.2.2016 at 6:00 p.m. The meeting was attended by Hon'ble Deputy Chief Minister, Commissioners (South & East Delhi Municipal Corporation), Addl. Commissioner (North Delhi Municipal Corporation), Engineer-in-Chiefs of SDMC & EDMC, Chief Engineer concerned from NDMC and Suptdg. Engineer(Plg.)/SDMC. The Special Secretary(UD) was also present in the meeting. The following decisions were taken in the meeting:

- 1. Initiating the discussion regarding the implementation of the works under DUDA, the Hon'ble Chief Minister and Deputy Chief Minister expressed their concern over the extremely slow pace of implementation of the works recommended by the respective MLAs and Mohalla Sabha works through DUDA. It was explained by the officers present that funds to the extent of 25% are only being released as first installment. This percentage has been found to be less when compared with the overall cost of works.
- 2. After detailed deliberations on the issue it was directed that the Municipal Corporations should undertake these works after receipt of 50% funds of the estimated cost of work from the GNCTD. The balance payment would be released after satisfactory completion of the works by the respective Corporations.

The meeting ended with a vote of thanks to the Chair.
