Sir,

As you are aware that vide this office order of even no. dated 16.7.2015, DUDA was created in each Revenue District for implementation of MLALAD Scheme. Further, vide order dated 16.10.2015, it was decided that procedures for execution of works under MLALAD Scheme through DUDA of Revenue Deptt. will be as under:-

MLAs may approach any one of the agencies authorized to execute works under MLALAD scheme, viz, I&FC, DSIIDC, DUSIB, MCDs, DISCOMs etc., for preparing estimates related to the various works proposed by them. Thereafter the letter for execution of the work, alongwith estimates, would be sent by the MLA to the office of the DM concerned, who will award work to the same agency which has prepared the estimates. It was clarified that henceforth DMs shall perform the same role as earlier performed by UD i.e. release fund under MLALAD scheme and monitor the progress of work.

However, each Revenue District sent each and every sanction letter to this department which is not required by this Department since monitoring of the progress of work is to be carried out by respective District. Utilization Certificates of whole amount released under MLALAD Scheme to each Revenue District will be sent to this department after completion of the financial year.

It is, therefore, requested to kindly look into the matter and necessary direction may be issued to all concerned in this regard with the request to upload each and every sanction in the respective district website.
