- 7. The work will be taken against Plan Fund and before execution it should be ensured that sufficient Fund under the scheme is available.
- 8. The audited accounts and utilization certificate for the year 2012-13 along with expenditure statement duly certified by the audit should be submitted as per GFRs.
- Plan funds under the MLA Local Area Development Scheme will utilized by the agencies strictly in accordance with the parameters of the scheme on approved item of work as amended from time to time.
- 10. The quarterly progress report (Financial and Physical) by various agencies (area wise) under MLALADS shall be intimated to Planning Department / UD Department.
- 11. The implementing agency will be responsible for technical and financial scrutiny and approval of detailed estimate for each work.
