Sir,

With reference to the aforesaid estimate submitted vide letter No.24(Gen)/Cf.Eng.Z-2/Exec.Eng.(Plg.)/5595 dated 29-09-2010 on the above subject, I am directed to convey the A/A & E/S of Secretary (UD) for Rs.101.58 lakhs (Rupees one crore one lakh & fifty eight thousands only) for carrying out the above work with the following conditions:

1. The expenditure involved is debited to the Major Head of Account- "5054" BB 11 (1) (1) (2) - under demand No.11 of the Govt. of NCT of Delhi for the year 2011-12.

2. The sanction cost consists of basic cost at DSR-2007 + 9% cost index + 1% each for contingencies, labour cess and 3<sup>rd</sup> party quality control. No additional fund will be provided.

3. Works should be completed within the scheduled time projected in the estimate.

4. Work shall be completed as per CPWD Manual/without any further revision/escalation.

5. Financing for the project shall be managed as per the scheme from the Budget Provisions.

6. Per unit Rate of cost of construction should be uniform for similar or near similar works.

7. The Administrative Department and/or Construction agency must not change the scope of work on its own. Such change, if any, shall be placed before Secy. (UD) for approval.


8. These works should maintain conceptual matching not only in a particular zone but also with all the works in other zones.

9. A completion report/certificate will be furnished to this office immediately after the work is completed. The work should be completed within the scheduled period and sanctioned cost.

10. It will be ensured that all the payments to the contractors is made through electronic fund transfer only.
